As a specialist in the use of integrated data for transdisciplinary research and policy development, I advocate for research-practice partnerships that place participant engagement at the forefront of methodological and programmatic decisions. My research approach to increasing stakeholder engagement has fostered the development of Florida's Sunshine State Data Portal, a statewide repository of administrative data related to socialized health and education services for families with children birth to five. Furthermore, the research strategies I have developed through engaging in this work have led to successful, ongoing collaborations with several research teams in the NIH Environmental Influences on Child Health Outcomes (ECHO) consortium. As a research methodologist, I am an expert in person-centered machine learning techniques, which are useful for understanding complex interactions, contextualized risk, and effect heterogeneity with the aims of evaluating and developing targeted interventions.
